Athletes whose applications are accepted by **Northstar Prep** will be required to pay the fees associated with the program, which account for the costs of training, gear, insurance, travel, etc. The academic support from Windsor Park Collegiate, our partner school, will assist athletes in maintaining the academic standard required to play, and will also provide assistance to compensate for the travel-intensive schedule. This program requires a great deal of commitment; the physical, mental and emotional toil that comes with training of this magnitude is not for everyone.

WAIVER OF LIABILITY

This agreement releases **Northstar Preparatory Institute** (“**NPI**”) from all liability relating to injuries that may occur during any basketball related activities. By signing this agreement, I agree to hold **NPI** entirely free from any liability, including financial responsibility for injuries incurred, regardless of whether injuries are caused by negligence.

I also acknowledge the risks involved in competitive sports and sporting events. These include, but are not limited to bodily injury, dehydration and cardiac events. I swear that my child is participating voluntarily, and that all risks have been made clear to me. Additionally, my child does not have any conditions that will increase the likelihood of experiencing injuries while engaging in physical activity.
